Exhibition/Artist-In-Action/Vendor Booth

ArtWalk Longmont organizes a series of summer festivals Downtown, each year providing venues for artists and arts enthusiasts of all ages to celebrate Longmont’s vibrant culture through active participation.

The 2017 ArtWalk season will feature two events, and artist participation is designed to best include and support artists, while improving ArtWalk for everyone! ArtWalk is a family-friendly, all-ages event, and can reject applications based on content. Application fees are non-refundable.

Exhibiting Artist: \$25 fee per event

Apply to partner with a local business to show your work during the event. Work must be ready to hang, and installation is a coordinated effort between you, the artist, and a local business owner. Please submit an artist’s statement and 3-5 images of your work, sized to 1000px on the shortest side, for consideration. If selected, the work will be exhibited during ArtWalk, and may be displayed for a longer period if agreed upon in partnership with the downtown business.

Artist-In-Action:

Bring your process to the street! ArtWalk will provide street space for a limited number of artists per event. Please submit a description of your process and 3-5 example images of your work, sized to 1000px on the smallest side. Artists-In-Action are allowed to sell their work during the event but we encourage you to bring an assistant to help with sales as you complete your work, and you must have a City of Longmont sales tax license.

Funding Supplies: \$10 fee per event

If your work is interactive, ArtWalk can help provide supplies! Funded Artists will be provided a tent and table, if quantities allow. Please include a brief description of your process and a detailed funding request.

Artist Vendor Booth: \$45 per event

If you would like to bring your work to sell at ArtWalk, reserve a booth space at the discounted rate of \$45. You must have a City of Longmont sales tax license. Booths are limited to a 10ftX10ft footprint: please contact us if you require additional space.

Artist Application waivers, disclaimers, and details

Mission Statement:

"ArtWalk is a cultural event series in Longmont for arts lovers and future arts lovers. We connect arts, business, nonprofit, and education to celebrate local creativity."

Exhibiting Artists:

Artist is responsible for delivery, installation, and removal of artwork in a timely fashion. ArtWalk volunteers and staff are available to assist but are not responsible for artwork included. Installation cannot permanently alter the location in any way: additional holes in the wall, markings, etc. Local businesses participate in the good faith that their operations will not be altered through participation, and it is crucial to that good faith that all installations respect their location. Exhibition is guaranteed for the date and time of ArtWalk events only.

Artists-In-Action:

Eligible recipients include non-profit arts organizations, arts educators, and individual working artists. Any supported artist or project must suit the mission statement of ArtWalk Longmont.

Artist is responsible for delivery, installation, and removal of artwork and project materials within the hours of setup and take-down for the event(s). ArtWalk volunteers and staff are available to assist if arranged in advance, but are not responsible for artwork or equipment. Artists must be present for the date(s) and time(s) of ArtWalk. ArtWalk does not provide tents or tables for non-funded artists and projects, though non-funded artists may be invited to participate. Electricity is not guaranteed, though it is available for select artists. Artists must possess a City of Longmont Sales Tax License to sell work during ArtWalk. All selected projects must be temporary and entirely removed at the end of the event.

Artist-In-Action funding recipients:

Eligible recipients include non-profit arts organizations, arts educators, and individual working artists. Funding is available for supplies and may be awarded at the discretion of ArtWalk Longmont Staff and Board of Directors, in amounts up to \$500. Funding may be awarded in a lesser amount than requested.

Applicants must submit a short description of the work and intended project that outlines how it will be produced and list supplies needed. Any supported artist or project must suit the mission statement of ArtWalk Longmont.

Artist is responsible for delivery, installation, and removal of artwork and project materials in a timely fashion. ArtWalk volunteers and staff are available to assist if arranged in advance, but are not responsible for artwork or equipment. Artists must be present for the date(s) and time(s) of ArtWalk. Electricity is not guaranteed, though it is available for select projects. Artists in this category are not permitted to sell work during ArtWalk. All selected projects must be temporary and entirely removed at the end of the event.

Booth Exhibitor:

Eligible registrants include non-profit arts organizations, arts educators, and individual working artists.

ArtWalk does not provide tents or tables for exhibitors.

Artist is responsible for delivery, installation, and removal of artwork within the hours of setup and takedown for the event(s). Artists must be present for the date(s) and time(s) of ArtWalk. Electricity is not available. Artists must possess a City of Longmont Sales Tax License to sell work during ArtWalk. Booths are limited to a 10ftX10ft footprint: please contact us if you require additional space.

Waivers:

By participating in ArtWalk, I understand that my likeness, that of any assistants I employ, and/or that of my work can and will be used for promotional purposes by ArtWalk Longmont, Inc. ArtWalk Longmont, Inc does not directly resell images or artwork. ArtWalk Longmont, Inc. is not responsible for artwork, supplies, personnel, or sales.
